## 1. General

- 1.1 D2B Studios is committed to providing all students with a safe, supportive, and inspiring environment.
- 1.2 All students and parents/guardians are expected to uphold the studio's values of respect, commitment, and positivity.

## 2. Enrollment and Attendance

- 2.1 Enrollment is confirmed upon receipt of the registration form and payment of the first month's fees. Registration link for new enrolments:  
A non-refundable enrolment/administration fee of **R400.00 (Cash)** is payable for each dancer/student enrolled. Enrolment fees are payable on the day of enrolment and strictly before a student's first class.
- 2.2 Regular attendance is essential for progress and participation in examinations, competitions, and showcases.
- 2.3 Students must arrive on time for classes and dress appropriately. Notify via WhatsApp on your given group if you are going to be late.
- 2.4 Dancers who miss the last 3 rehearsals before any performance may be pulled out of the team at the teacher's discretion.**
- 2.5 Dancers are more than welcome to join their school revue. Please note that if a dancer's revue rehearsals overlap with our regular class rehearsal schedule, they will not be able to participate in group competition routines, as consistent attendance is essential for team preparation. Please bear in mind that this applies to extra rehearsals during our competition season.

## 3. Payments

- 3.1 Payments are required from February to December of each year.
- 3.2 Fees are due on the 5th of each month and must be paid via EFT with the reference provided in red on your monthly statement.
- 3.3 Late payments may incur a late fee of R200 per month until the account is settled in full. Students with account balances of >90 days will not be allowed to participate in classes until the account is paid.
- 3.4 Fees are non-refundable, except in cases of extended medical absence, with a doctor's certificate provided.
- 3.5 Life happens and unforeseen circumstances are our reality, therefore arrangements can be made regarding overdue accounts. If your account remains unpaid, you will be given 3 notices before your account will be handed over to Bredell & Ferreira.
- 3.6 We have 2 Bank accounts. The D2B Studios account is ONLY for monthly class fees, the second account is for everything else. Failure to pay into the correct account will be seen as not paid. Please make sure that you understand.

## 4. Examinations, Competitions, and Showcases

4.1 Participation in dance examinations is compulsory to move up to the next level. Local competitions and the annual October showcase are encouraged but not mandatory.

4.3 Students are expected to attend all required rehearsals for performances and events necessary.

4.4 All Examinations, Competitions, Outfit, and Showcase fees are to be paid into the account listed below.

## 5. Studio Policies

5.1 D2B Studios is not responsible for lost or stolen items. Students are encouraged to keep their personal belongings secure.

5.2 Food and drinks, except water, are not permitted in the studio.

5.3 The studio reserves the right to make changes to the class schedule or instructors when necessary.

5.4 D2B is a 'drop & go' studio, meaning parents are not permitted in classes, except for the first trial class and the last class of each term.

5.5 **Sibling Supervision:** D2B Studios is not responsible for the supervision of siblings or children who are not enrolled in classes. Parents/guardians are required to ensure that any accompanying siblings remain under their supervision at all times.

- Siblings are not permitted to enter the dance studio floor or interfere with classes.
- Any disruptive behavior from unsupervised siblings may result in the parent/guardian being asked to leave the premises with them.

This policy ensures a safe and focused environment for our students and instructors.

## 6. Health and Safety

6.1 Students must inform instructors of any medical conditions or injuries before participating in class.

6.2 D2B Studios follows all necessary health and safety protocols to ensure a safe environment for students and staff.

6.3 In the event of an emergency, parents/guardians will be contacted immediately.

6.4 D2B Studios do not accept responsibility, direct or indirect, and will not be held liable for any accident or death, injuries, illness, damage, and/or losses suffered by you and/or the student during dance lessons, rehearsals, performances, functions, outings, and tours and you hereby agree to indemnify and hold harmless D2B studios and it's employees in the event of any such occurrences.

## **7. Code of Conduct**

D2B Studios is committed to fostering a supportive and respectful community. We believe that everyone has the right to feel safe and valued while participating in our classes, events, and performances. Any behavior that undermines this will not be tolerated.

D2B Studios is committed to fostering a safe, positive, and respectful environment for all students, parents, and instructors. To ensure this, all participants are expected to abide by the following guidelines:

### **7.1 Respect for Instructors and Peers:**

- Students must follow the instructions of their teachers and respect their authority during classes, rehearsals, and events.
- Respectful language and behavior are required at all times. Disrespectful conduct, including backtalk, interrupting, or ignoring instructions, will not be tolerated.

### **7.2 Bullying and Disruptive Behavior:**

D2B Studios enforces a strict zero-tolerance policy for bullying, harassment, or disruptive behavior. This includes but is not limited to:
